

## **SEMINAR TERMS AND CONDITIONS**

of Future Dental Academy GmbH Champions Platz 1, 55237 Flonheim, HRB 48177 Amtsgericht Mainz (District Court Mainz)

### 1. Contract formation

- (1.1) Contracts between seminar participants or clients and the organizer (Future Dental Academy GmbH), as well as any amendments or supplements, shall be in writing.
- (1.2) Deviating terms and conditions of the client shall not apply.
- (1.3) During the event, the participant acknowledges the organizer's house rules.

## 2. Services of the Organizer

- (2.1) Trainers have the sole responsibility for designing and delivering their lectures. The organizer can make changes to the program (e.g. substitute speaker), provided these are reasonable for the participant. If an event cannot take place for important reasons (e.g. illness, force majeure, venue issues), the organizer is entitled to designate a replacement date/location. The right of withdrawal in such cases is excluded. Replacement events may take place online or on site.
- (2.2) Scope, format, content, and objectives of the services are known to the participant/client.
- (2.3) Copyright to the materials created by the trainer remains with the trainer. Written consent must be obtained before reproduction or distribution.
- (2.4) Hygiene and infection control measures are subject to applicable law and are communicated before the seminar begins. By registering, the participant agrees to comply. Special cancellation rights due to official measures do not apply.
- (2.5) The participant agrees to photo, audio, and video recordings during the event and their use for publicity purposes.

## 3. Payment Terms and Cancellations

- (3.1) When booking a seminar, a 30% deposit of the seminar fee is due immediately upon receipt of the invoice.
- (3.2) The remaining 70% must be paid no later than 3 months before the seminar begins. For short-term registrations, the total amount is due immediately.
- (3.3) Discounts or rebates outside of invoicing are excluded.
- (3.4) Participation is only possible after full payment. For cancellations up to 3 months before the start, 30% is due; thereafter, 100%. If you change your booking, these deadlines will apply based on the original date. A substitute participant may be named up to 10 days before the seminar starts for an administration fee of €25. Cancellation after the seminar has begun is not permitted.
- (3.5) You can change your booking once free of charge up to 4 weeks before the seminar begins, provided the fee has been fully paid. There is no entitlement to changing your booking.
- (3.6) Free additional places are not transferable and expire if not used.
- (3.7) Invoices are sent by email to the provided address.
- (3.8) Accommodation costs are not included in the seminar price and must be borne by the participant.
- (3.9) Bank fees for transfers are borne by the participant.
- (3.10) Installment payments may be agreed upon by mutual consent. In case of default on payments, the entire amount becomes due immediately. Participation requires full payment.

# 4. Power Days / Keynote Lectures

For bookings, the full admission fee is due immediately. Cancellation is excluded. Substitute persons may be named.

## 5. Copyright

All content is protected by copyright. Any recordings, reproduction, or distribution of any part of content are prohibited without permission. Misuse can result in claims for damages. The organizer can apply invisible watermarks to digital content.

### 6. Data Protection

- (6.1) Personal data are processed for contract fulfillment in compliance with the GDPR (general data protection regulation DSGVO in German). Details: https://future-dental-academy.com/datenschutz
- (6.2) Inventory data may be passed on to third parties for assignment or collection of claims.

# 7. Product Delivery via the Champions Online-Shop

- (7.1) The purchase contract is concluded upon dispatch of the goods.
- (7.2) The buyer is liable for damage resulting from improper use. No liability is accepted for hardware damage caused by copy protection (except in cases of breach of essential contractual obligations).
- (7.3) Delivery is made to the specified address via Hermes or another suitable shipping method for international deliveries.
- (7.4) Discounts and unlisted rebates are excluded. For intra-community deliveries, a valid VAT Registration No. is required. For deliveries to third countries, VAT exemption applies.
- (7.5) Goods remain the property of Champions-Implants GmbH until full payment is received.

## 8. Final Provisions

- (8.1) The invalidity of individual clauses does not affect the validity of the remaining provisions.
- (8.2) German law exclusively applies.
- (8.3) The place of jurisdiction is the registered office of the organizer.
- (8.4) The participant agrees to receive updates via email or mobile.
- (8.5) Note: The seminars are intended for mentally healthy individuals. They do not constitute a medical measure. In case of psychological problems, medical advice must be sought before participation.
